### **Superintendent's Report**

Dr. Larry D. Leapley, Interim Superintendent of Schools, reported the following:

- 1. On June 14, 2012, the superintendent was able to recall a total of eight teachers and one school psychologist. This is the same number of staff the district laid off on Monday, April 16, 2012 and May 14, 2012. Seven teachers have responded to their recall letters and accepted returning to teaching positions with the school district. Today one of our recalled teachers chose to remain in the district where the teacher is currently employed. Tomorrow we will recall another teacher from our lay off list and this will mean we have only one teacher left on the district's layoff list. Hopefully, we will be able to recall that teacher by the beginning of the school year.
- 2. Principal Stephanie O'Connor and Assistant Principal Debbie Waple and eight other Arthurs Middle School teachers attended the Schools to Watch Annual Conference in Washington, DC on Wednesday, June 20 to Saturday, June 23, 2012. In addition to learning about other middle school curriculums and activities the teachers and administrators were honored as one of the new members of the Schools to Watch program presented by National Forum. The following teachers attended the conference: Tracy Kersten, Val DePaoli, Jodie Sejnost, Lorna Hardin, Debbie Rossi, Gail Vos, Beth Stackpole, and Yvette Gronda.

# REPORTS AND RECOMMENDATIONS FOR ACTION

## Adoption of Annual MHSAA Membership Resolution

The Board adopted the following Membership Resolution for the Michigan High School Athletic Association:

THE TRENTON HIGH SCHOOL AND BOYD W. ARTHURS MIDDLE SCHOOL, SECONDARY SCHOOLS WHICH ARE UNDER THE DIRECTION OF THIS BOARD OF EDUCATION OF THE TRENTON PUBLIC SCHOOLS, CITY OF TRENTON, COUNTY OF WAYNE, OF STATE OF MICHIGAN, ARE HEREBY:

- (A) ENROLLED AS MEMBERS OF THE MICHIGAN HIGH SCHOOL ATHLETIC ASSOCIATION, INC., A NONPROFIT ASSOCIATION, AND
- (B) ARE FURTHER ENROLLED TO PARTICIPATE IN THE APPROVED INTERSCHOOL ATHLETIC ACTIVITIES SPONSORED BY SAID ASSOCIATION.

THE BOARD OF EDUCATION/GOVERNING BODY HEREBY DELEGATES TO THE SUPERINTENDENT OR HIS/HER DESIGNEE(S) THE RESPONSIBILITY FOR THE SUPERVISION AND CONTROL OF SAID ACTIVITIES, AND HEREBY ACCEPTS THE CONSTITUTION AND BY-LAWS OF SAID ASSOCIATION AND ADOPTS AS ITS OWN THE RULES, REGULATIONS, AND INTERPRETATIONS (AS MINIMUM STANDARDS), AS PUBLISHED IN THE CURRENT HANDBOOK AS THE GOVERNING CODE UNDER WHICH THE SAID SCHOOLS SHALL CONDUCT ITS PROGRAM OF INTERSCHOLASTIC ATHLETICS AND AGREES TO PRIMARY ENFORCEMENT OF SAID RULES, REGULATIONS, INTERPRETATIONS, AND QUALIFICATIONS. IN ADDITION, IT IS HEREBY AGREED THAT SCHOOLS WHICH HOST OR PARTICIPATE IN THE ASSOCIATION'S MEETS AND TOURNAMENTS SHALL FOLLOW AND ENFORCE ALL TOURNAMENT POLICIES, PROCEDURES AND SCHEDULES.

THIS AUTHORIZATION SHALL BE EFFECTIVE FROM AUGUST 1, 2012 AND SHALL REMAIN EFFECTIVE UNTIL JULY 31, 2013, DURING WHICH THE AUTHORIZATION MAY NOT BE REVOKED.

# **Approval of Year-End Budget Amendments**

Mrs. Gail Farrell, Business Manager, reported a budget amendment was adopted on January 18, 2012, that decreased revenues by \$312,104 and decreased expenditures by \$102,770 decreasing the projected fund balance to \$1,044,909. Year-end budget adjustments were done at the June 11, 2012, board meeting that increased revenues by \$514,924 and decreased expenses by \$474,861 resulting in an estimated fund balance of \$2,034,694. Since the June 11, 2012, board meeting the administration has received some retirement notices and unexpected additional costs in areas such as transportation and instruction. The district is required to amend the 2011-12 budget in different functions but with a net effect of zero. The projected fund balance will remain the same; however total expenses will change in some of the individual function areas. Budget amendments are approved at the function level and are outlined in the agenda item on Board Docs Pro https://www.boarddocs.com/mi/trenton/Board.nsf.

The Board approved the budget amendments as presented at the function level as requited for the General Fund (with a net effect of zero) and as shown in the May 2012 amendments column of the budget.

### Adoption of Textbooks for High School French Courses

Mrs. Ann Deneroff, Director of Curriculum, reported current French texts have a copyright date of 1994 and are not up-to-date in terms of vocabulary, internet resources, and alignment to State Standards.

Eight French texts were reviewed by the French teacher, Lisa Asquini, and input was sought from the American Association of Teachers of French regarding the top two choices. The *Discovering French* series is being recommended for the following reasons:

- Modern topics and vocabulary
- Excellent scope and sequencing of lessons, pacing guides, and appropriate level of difficulty for high school students
- Alignment with State Standards including areas of reading, writing, listening, speaking, grammar, and culture
- Smooth transitions between levels including review at the beginning of each level Supplementary resources including online features, such as audio flashcards, self-scoring quizzes, and listening practice.

The plan is to implement Level 1 and possibly Level 2 for the 2012-13 school year. The need for Level 3 will be assessed before a decision is made to implement Level 3 in French III and IV. The following textbooks by J. P. Valette and R. Valette, published by McDougall Littell were approved by the Board:

# Board Action on Transportation Services for the 2012-13 School Year

Dr. Larry D. Leapley, Interim Superintendent, Mr. Rodney R. Wakeham, Superintendent effective July 1, 2012, and Mr. Vince Porreca, Principal, Hedke Elementary School, briefly reviewed the action to date and options available to the school district with respect to transportation services for the 2012-13 school year. As previously reported the three different options available for the Board of Education are (1) Continue transportation as it is now, (2) Eliminate General Education Busing – provide only Special Education (required by law) and special trips through our current staff, and (3) Contract out transportation to an independent firm to maintain full service transportation. The Administration presented the following recommendation on transportation services for the 2012-13 school year for Board consideration:

- To maintain the quality of our educational programs in the Trenton Public Schools is an increasingly difficult task due to budget conditions outside of our control.
- Our full service busing program including, general education, special education, mid-day busing, field trips, and athletic trips is an important component of our educational success.
- We believe student enrollment and attendance as well as the quality of our educational programs would degrade without busing.
- Therefore we believe that the evidence based on our comparison of the Request for Proposals supports a recommendation to contract with a third party to provide us with a full service bus program for the Trenton Public Schools.
- The evidence we have researched, gathered, analyzed and witnessed leads us to recommend that the board select Dean Transportation.
- If the board agrees with and approves this recommendation, the Administration would begin negotiations with Dean Transportation to develop a contract that best supports the school district and our transportation goals, which includes fair and equitable treatment of our current staff during this transition.

Mr. Wakeham concluded contracting transportation services will reduce the age of the bus fleet, eliminate variable cost of maintenance, and that Dean Transportation will provide acceptable wages, maintain seniority and bidding rights of our transportation staff.

The Board accepted the Administration's recommendation and authorized the Superintendent of Schools to begin negotiations with Dean Transportation to provide transportation services to the Trenton Public Schools for the 2012-13 school year, and to develop a contract that best supports the school district and our transportation goals, which includes fair and equitable treatment of our current staff during this transition.
